KNOW ALL MEN BY THESE PRESENTS, that whereas the undersigned is the record owner of Lots 29 through 36, Block 3; Lots 18 through 29, Block 5; Lots 17 through 42, Block 2; and Lots 12 through 15, Block 6, all in Bellaire Addition "A" to the City of Bellevue, Sarpy County, Nebraska.

NOW THEREFORE THE FOLLOWING RESTRICTIONS AND PROTECTIVE COVENANTS ARE HEREBY PLACED ON SAID LOTS,

TO WIT:

- 1. All lots shall be used for residence purposes only.
- 2. No structure shall be altered, erected, placed or permitted to remain on any lot other than one detached, single family dwelling, not to exceed two stories in height, and a private garage for not more than two cars.
 - 3. No building shall be located nearer than 5 feet to any side lot line.
- 4. No building shall be located on any one of these lots nearer than 35 feet to the front lot line, except Lot 36, Block 3, upon which a variance has been granted by City of Bellevus, due to the curvature of the East entrance of Bellaire Boulevard.
- 5. No residence shall be erected or placed on any of these lots which lot has an area of less than 9800 square feet, nor a width of less than 66 feet.
